

Who are Unpaid Carers?

An unpaid carer is a person (including children and young adults) who supports a family member, friend or neighbour who, due to illness, disability, mental health challenges or addiction could not manage without this support.

People with caring responsibilities may not use the term 'carer' to describe their relationship.



Instead of 'Are you a carer?' aim for more open conversations.

Some prompts:

- Who helps you at home?
- Do you help your mum with ...?'
- Would your brother struggle to do ... without your help?

Carers Legal Rights

Care Act 2014

Main legislation governing rights of unpaid carers and adults with support needs.

The Children & Families Act 2014

Sets out the rights of young carers, children with additional needs and their carers.

Health and Care Act 2022

Strengthens rights of unpaid carers, of any age, to be involved in health and care decisions of the person they support.

Carers Leave Act 2023

Entitles unpaid carers to one working week's worth of unpaid leave per year for caring responsibilities.

Carers in hospital

- With consent, record carer details on medical records
- Involve carers in decision making and care planning, as appropriate
- Even without the patient's consent to share information, you can offer carers general information, listen to their concerns and signpost to support.
- Inform carers about their rights and support available to them, or complete an external referral for support on their behalf (if they consent to this)
- Offer the Hospital Carers Passport



Local areas operate carer contingency plan schemes, a document planning for temporary provision of care to the person needing support should their usual unpaid carer suddenly find themselves unable to carry out their caring responsibilities. Plans need to be registered in advance but following registration, the plan will be available to be used in an emergency. (Names for local schemes may differ between areas).
